

Have your tax returns prepared and e-filed for free and receive up to \$5,657 additional cash back when you claim the **Earned Income Tax Credit (EITC)**. *Your household income must have been less than \$49,000 in 2009 to qualify for free tax preparation.*

**WHAT YOU NEED TO BRING:**

- All W-2's and 1099's
- Social Security Cards or Individual Taxpayer Identification Numbers (ITIN) for all family members
- Valid picture ID for taxpayer and spouse (Driver's License, State ID, Passport)
- Copy of 2008 tax return
- 1098 or real estate tax receipt
- Proof of unemployment compensation
- A copy of a "voided" check or bank account and routing numbers for direct deposit
- Proof of child care expenses
- Amount of Advanced EITC payment, if any
- Sales tax receipt for new auto purchase
- If married filing jointly – both spouses must be present to sign
- Parcel number (Illinois homeowners only)
