

WHY SHOULD YOU PAY TO GET YOUR OWN MONEY BACK?

WHAT YOU NEED TO BRING:

- All W-2's and 1099's
- Social Security Cards or Individual Taxpayer Identification Numbers (ITIN) for all family members
- Valid picture ID for taxpayer and spouse (Driver's License, State ID, Passport)
- If married and filing jointly, both spouses must be present to sign
- Copy of 2010 tax return
- 1098 or real estate tax receipt
- Proof of unemployment compensation
- A copy of a voided check or bank account and routing numbers for direct deposit
- Proof of child care expenses
- Amount of advanced EITC payment, if any
- Parcel number (Illinois homeowners only)

- With schedule B, C (\$10,000 limit), EIC & R
- Form 1040 - V
- Form 1040 - ES
- Form 2441 (Child and dependent care credit)
- Form 8863 (Education credits)

Gateway EITC Community Coalition (GECC) is a non-profit organization dedicated to preparing tax returns free of charge for families with incomes less than \$50,000. Since 2002, we have prepared more than 26,800 federal returns at no charge for our clients and brought more than \$32 million in refunds to the community.

DO YOU QUALIFY?

Come to one of our **FREE** tax preparation sites and have your tax return prepared and e-filed for free by one of our IRS trained and certified tax preparers. Receive your refund in 7-10 days when you take advantage of **FREE**, fast, direct deposit. You may also qualify to receive up to \$5,751 cash back when you claim the Earned Income Tax Credit (EITC). Your household income must have been less than \$50,000 for 2011 to qualify for free tax preparation. Simply dial 2-1-1 to learn if you qualify or to find the nearest site.
